The People's Republic of China implements a work permit system for foreigners working in China. After receiving this notification letter of the Work Permit, foreigners shall go through the following procedures:

- 1. Present the notification letter and other relevant documents to the embassy, consulate office of the People's Republic of China or other agencies stationed abroad entrusted by the Ministry of Foreign Affairs when applying for a Z Visa.
- 2. Within 30 days of entry into the People's Republic of China, present the notification letter and other relevant documents to the exit and entry administration of the public security authorities where the employer is located to apply for a work-type residence permit.
